#### Greetings,

As the calendar turns to May, we can firmly say that Winter is behind us and Summer is on the horizon. I hope everyone is doing well. It was great to see so many of you at our Spring conference. We received a lot of positive feedback regarding the Hilton at Polaris and I believe that the Executive Committee will be looking to return to this location in the future. Our next conference is scheduled for June 21-22 and will be taking place at the Hotel Breakers in Cedar Point. An agenda detailing the training opportunities will be sent out in the very near future. I hope to see all of you there.

Regarding potential legislation at the Statehouse, there has been very little activity through the first quarter of the year. However, now that the primary elections have been completed things are starting to pick up. The House and the Senate each have competing legislation regarding the legalization of marihuana and Director Tobin and I have been busy meeting with legislators trying to get something passed that honors the voters decision to legalize marihuana but provides guidance to law enforcement and reasonable limitations regarding the use, sale, and cultivation of the drug. There continues to be a push by some legislators to expand record sealing, now by removing the requirement for people to come forward to apply. One proposal would require BCI to send a list of eligible cases to prosecutors and courts every month and those cases would be sealed if the prosecutor did not object for limited reasons. Another proposal would require the Common Pleas Court to automatically initiate the motion to seal on behalf of the defendant.

I would encourage all of you to stay involved with our Association and please take advantage of the brief bank, legislative updates, trainings, and the many opportunities to get involved. Thank you for your all your hard work. I can't wait to see you all in June.


#### Prosecutors -

I want to take a moment this month to recognize Sherri Bevan Walsh who retired as Summit County Prosecutor in February after serving as the elected prosecutor for almost 25 years. Her retirement party in Akron, attended by 300 plus people, was a testament to the impact that Sherri has had on her community and on the lives of the victims of crime. Sherri was also a great asset to the OPAA, serving as part of OPAA's leadership for many years and as President of the Association in 2010, and to prosecutors across the state who she regularly mentored and advised. On behalf of OPAA – best wishes to Sherri in her retirement.

One of the hottest topics in the General Assembly right now is artificial intelligence. Just in the last six months, four bills have been introduced related to artificial intelligence and that have criminal components to them. House Bill 295 updates the law regarding the nonconsensual dissemination of private sexual images to include "deepfake" sexual images. The bill also creates a criminal statute that requires pornography websites to use age verification. House Bill 367 prohibits the unauthorized preparation, production, development, distribution, exhibition, or exchange of "malicious deepfake recordings." House Bill 401 prohibits the use of "deepfakes" to harass, extort, threaten, or to cause physical, emotional, reputational, or economic harm. Senate Bill 217 prohibits simulated child pornography and also identity fraud using a replica of a person. This is a topic that prosecutors will want to pay close attention to in the coming months given the potential uses of this technology to harm numerous victims with relative ease.

I look forward to seeing many of you at our Summer Workshop at Cedar Point.

#### At the Statehouse

#### Legislative Top 10 Bills to Watch

- 1) House Bill 51 (Second Amendment Preservation Act). Prohibits a public office, public officer, or employee of the state or a political subdivision from enforcing federal law regarding firearms. Subjects the state or political subdivision to liability through a private cause of action for enforcing, attempting to enforce, or participating in any way in the enforcement of federal acts, executive orders, administrative orders, rules, regulations, statutes, or ordinances regarding firearms and for employing any former federal employees who worked on such issues while in federal employment. OPAA Position Opposed.
- 2) Senate Bill 127/House Bill 161 (Eliminate Spousal Exception for Sexual Assaults). Eliminates the spousal exceptions for the offenses of rape, sexual battery, unlawful sexual conduct with a minor, gross sexual imposition, and importuning and permits a person to testify against the person's spouse in a prosecution for one of these offenses. OPAA Position Monitor.
- 3) House Bill 385/Senate Bill 214 (Human Trafficking Victim Record Expungement). Allows victims of human trafficking to expunge records of misdemeanors, F5, and F4 offenses without requiring that they have a prior conviction for

- offenses without requiring that they have a prior conviction for soliciting, loitering to engage in solicitation, or prostitution as required by current. Victims who apply for expungement under the bill will have to demonstrate by clear and convincing evidence, rather than a preponderance, that the offense was the result of the applicant being a victim of human trafficking. OPAA Position Monitor.
- 4) House Bill 86/House Bill 354 (Adult Use Marijuana Implementation). Both bills make changes to the language of Issue 2 and the Adult-Use Marijuana program. House Bill 86 was amended by the Senate in December 2023 to make substantial changes to Issue 2 including provisions on home grow, THC limits, use, possession, and transportation, smoking in a vehicle, and the social equity and jobs program. House Bill 354 in the House's vision of Issue 2 implementation. It makes much more limited changes to Issue 2 that include minor tweaks to use, possession, and transportation. OPAA Position Under Review/Amend.
- 5) House Bill 111 (Domestic Violence Penalties). Makes felony domestic violence a "high-tier" F3 subject to a sentencing range of 1 to 5 years rather than 9 to 36 months. OPAA Position Support.
- 6) House Bill 230 (Drug Trafficking/Organized Trafficking of Person). Increases penalties for trafficking cocaine, heroin, fentanyl, and methamphetamine. Creates a 5-year sentencing specification for involuntary manslaughter related to a fentanyl overdose death. Removes provisions from the drug possession law related to Schedule III, IV, and V drugs mixed with fentanyl. Creates the offense of offense of organized trafficking in persons. OPAA Position Support.
- 7) House Bill 56 (Fleeing/Stunt Driving). Increases the penalties for fleeing and eluding and amends the street racing statute to include acts of stunt driving and street takeovers. OPAA Position Support.
- 8) House Bill 91/Senate Bill 100 (Tracking Devices). Prohibit a person from using a tracking device or application to track the position or movement of another person without the other person's consent. A violation is a misdemeanor of the first degree for a first offense. The penalty is enhanced to a felony of the fourth degree for any subsequent violation and under other specified circumstances similar to those in the menacing by stalking statute. OPAA Position Support.
- 9) Senate Bill 101/House Bill 259 (Death Penalty Repeal). Repeals the death penalty. OPAA Position Opposed.
- 10) Senate Bill 223/House Bill 366 (Organized Retail Theft). Enacts the Fight Organized Retail Crime and Empower Law Enforcement (FORCE) Act. The bills authorize the Organize Crime Investigation Commission to establish an organized retail theft task force, create the crime of organized retail theft, increase the penalties for theft of mail, increase the penalties for criminal

mischief involving a retail pump, and update counterfeiting to address credit card "skimming." OPAA Position – Amend.

#### Merit Decisions of Interest Since 2/1/24

State v. Williams, \_\_\_\_ Ohio St.3d \_\_\_\_, 2024-Ohio-1433. In a case in which the defendant committed a homicide and then disposed of the weapon two days later, the Court unanimously concluded that the juvenile court's bindover of the homicide charge allowed a charge of tampering with evidence also to be brought in adult court, even though the tampering charge had not been raised in juvenile court. The 4-justice majority concluded that the tampering charge could be brought because it was "rooted in" the homicide charge that was the basis for the bindover. Three concurring in

judgment only would have overruled the "rooted in" test and upheld the tampering charge based on the adult court's statutory authority under R.C. 2151.23(H) to hear and determine charges other than just those that were expressly bound over. (Decided 4-18-24; State's appeal; Hamilton County)

State v. Carter, \_\_\_ Ohio St.3d \_\_\_, 2024-Ohio-1247. Five justices concluded under a Sixth Amendment analysis that the trial court's travel-related and COVID-related findings were insufficient to allow remote video testimony in a February 2022 trial by a witness who would need to travel from Minnesota. The term "services" as used in R.C. 9.48 does not include
"construction" or "construction services." 2019 Att'y Gen.
No. 2019-028 followed. However, the term "services" may
cover the installation, maintenance, repair, and the like of
items acquired under R.C. 9.48 provided such services to not
constitute nor cross into construction or construction
services. Whether any particular service acquired under R.C.
9.48, including any repair, maintenance, replacement,
installation, or upgrade constitutes "construction" or
"construction services" is a question of fact beyond the
opinion-rendering function of the Attorney General.
