qual Justice offers prosecutors, investigators and other allied child abuse professionals the necessary foundation to completely handle cases of child abuse. Increasing child abuse

caseloads, rapid turnover of personnel, and the common practice of rotating prosecutors among assignments all lead to a need for high quality, affordable training in the basics of child abuse prosecution. For experienced prosecutors, this course gives an overview of the latest case law, defenses, and strategies for investigating and prosecuting child abusers.

The field of medicine and science evolves. The legal landscape shifts. Improvements in the field of forensic interviewing are carefully reviewed and revised based on an analysis of best practices. Advancements in technology cause for unique investigations and prosecutions. Participants will explore the linkages between child abuse, intimate partner violence and animal abuse. Medical presentations will focus on the cases we often struggle to investigate appropriately, such as fractures, child neglect, bites, and burns. Equal Justice leaves participants equipped with the skills to appropriately interview child victims and to investigate and prosecute cases of child abuse.




#### RESERVATIONS


