Dear OPAA -

At our most recent Executive Committee meeting someone asked whether the remarkable rise in violence over the last 18 months is being noticed by the General Assembly. Personally, I think it is impossible to ignore when practically every morning the news coverage is about the most recent homicide or shooting. I do think the mood at the Statehouse is starting to shift there. Unfortunately, that still leaves us with big criminal justice reform battles on issues like abolishing the death penalty and, most recently, bipartisan bail reform legislation.

I met recently with a legislator to talk to him about our concerns with the bail reform bills. He told me in no uncertain terms that Senate Bill 3 was defeated last year because legislators were getting calls from their prosecutors, sheriffs, and judges and then going to legislative leadership to tell them they didn't want go against their local officials. I can't stress enough how important a similar grassroots effort will be on both bail reform and the death penalty. The great advantage that we have over the army of lobbyists advocating for these bills and the disinformation they circulate are your local connections. Please consider contacting your own legislators to express concerns about these bills and remind them that the groups promoting them have no responsibility to your community or for public safety in Ohio.

Finally, a note about John Murphy. I have been around capitol square in a variety of roles for the past 15 years, most of that time working on justice system issues. I had the opportunity to work on many of the same issues that John was working on and always knew what a great lobbyist he was for the OPAA. What I couldn't comprehend until I replaced him is just how gifted he was as a lawyer and how tough he was as an advocate. He had a legal mind that was second to none, a sharp wit, and was a consummate professional. The state of Ohio is a better place because of him and he will be missed.

John Edward Murphy, whose legal career representing the interests of Ohio's prosecutors spanned more than four decades, passed away peacefully on Thursday, July 8. He was 80. Born March 7, 1941, in Olney, MD, to John Edward, Sr. and Ethna Register Murphy, John was later raised in Parkersburg,

W.Va. He graduated from Parkersburg High School in Parkersburg W.Va., in 1959. John then went on to West Virginia University, where he graduated in 1963 with a bachelor's degree in economics. John entered the U.S. Army, serving honorably for four years. He earned the rank of Captain with postings at Fort Sill, Oklahoma; Karlsruhe, Germany; and Fort Benning, Georgia. Following his service, he entered and graduated with a law degree from Capital University Law School in Columbus, Ohio in 1972.

John began his legal career in the Franklin County (OH) Prosecuting Attorney's office. But the majority of his professional career was spent as executive director of the Ohio Prosecuting Attorneys Association. The organization was founded in 1937 to represent the interests of and provide professional development to Ohio's 88 elected county prosecutors. John had a passion for the law and the responsibilities of prosecutors. He spoke of these public servants "who are truly on a quest in the pursuit of justice for all of our citizens." "Prosecuting attorneys serve as 'ministers of justice' — indeed, they are justice-driven," he once wrote. "This applies to putting criminals behind bars and making sure the punishment fits the crime. But their work also entails making sure that people innocently accused of committing a crime are not ultimately charged or convicted."

John spent 37 years representing the prosecuting group's law-and-order positions before legislators as they crafted state laws. When he retired in September 2017, the Columbus Dispatch called him a "statehouse fixture" and he was feted in a celebration in the Ohio Statehouse Atrium.

In his retirement, John never strayed too far from his beloved Columbus, enjoying golf games with buddies and frequent trips to the Tremont Library in Upper Arlington.

John is survived by a daughter, Catherine Murphy (John Nagy) of West End, N.C.; and sister, Mary Ann Shaw (Jerry) of Parkersburg, W.Va.

He was preceded in death by his parents, a sister Joan Marks (Walter), and his son Michael Sean Murphy, formerly of Pinehurst.

New and Noteworthy

Merit Decisions of Interest Since 5/1/21

St. v. Azeen, ____ Ohio St.3d ____, 2021-Ohio-1735. In the absence of a negotiated plea agreement showing an express or implied reservation by the state of the right to file additional charges and that a defendant had been induced into offering a guilty plea, the state may pursue additional charges when a victim of a crime later dies of the injuries sustained in the crime – State was entitled to file aggravated-murder charges when victim later died of injuries suffered years earlier – No plea agreement was entered on the record when defendant was initially charged with attempted murder – Inference of a plea agreement was not supported by facts in evidence. (Decided May 25, 2021) (State's Appeal; Cuyahoga County)

- **St. v. Tidwell**, ___ Ohio St.3d ____, 2021-Ohio-2072. The inperson tip from an unidentified informant "Hey, you need to stop that vehicle. That lady is drunk." had some indicia of reliability and was sufficient to support reasonable suspicion to allow a *Terry* stop to investigate the possible OVI offense when combined with the officer's personal observation of very slow driving and a blank stare. (Decided June 24, 2021) (State's appeal; Hamilton County)
- **St. v. Worley**, ____ Ohio St.3d ____, 2021-Ohio-2207. Death sentence upheld in a case involving the extended kidnapping and asphyxiation killing of 20-year-old female victim. (Decided July 1, 2021) (Fulton County)
- **State v. Brinkman**, ___ Ohio St.3d ___, 2021-Ohio-2473. Guilty pleas and death sentences reversed in triple-homicide case because of plea-advisement error in failing to give oral advisements on right to confrontation and right to proof beyond a reasonable doubt. (Decided July 21, 2021) (Cuyahoga County)
- Gabbard v. Madison Local School Dist. Bd. of Edn., ____ Ohio St.3d ____, 2021-Ohio-2067. R.C. 1901.12 does not permit municipal-court judges to rollover unused vacation days to future years.

2021-016

Requested by: Symmes Township Law Director

A township road is an established public road if it satisfies the requirements of R.C. 5535.01(C).

Requested by: Cuyahoga County Prosecuting Attorney

Cuyahoga County lacks the authority to establish an electric utility when consent of the municipalities has not been given.

Requested by: Richland County Prosecuting Attorney

A county satisfies its duty, pursuant to R.C. 1901.111 and 1901.312, to pay a two-fifths share of the "costs, premiums or charges" for the group health care coverage by paying two-fifths of the employer share of premiums or funding levels established by the city.

If a township's town hall is located in the same building as office space, and if the township proposes to renovate both the office space and the town meeting hall, R.C. 505.26 prevails over R.C. 511.01 whenever the majority of the cost of the work will be allocated to renovating office space.

When a county treasurer-elect resigns prior to the start of the elected term, the person appointed to fill the vacancy will hold office until a successor is elected at the next general election for state and county officers.

A deputy sheriff may not simultaneously serve as a township trustee in a township that contracts with the county sheriff for law enforcement services.

Due to an impermissible conflict of interest, an appointed part-time city prosecutor may not simultaneously maintain a private practice in which he represents criminal defendants for violations of state law in the surrounding jurisdictions of the served municipal corporation.

A board of county commissioners has the final-say authority over the recommended road repair/improvement projects prepared by a county engineer.

2021-008

Requested by: Clermont County Prosecuting Attorney

The clerk of a county municipal court is not required to accept possession and control of records of mayor's courts relating to inactive cases of a village upon the dissolution of that village.

2021-007

Requested by: Portage County Prosecuting Attorney

The transfer of money from the county general fund to an "elections revenue fund" is not authorized unless it is approved by a county board of commissioners' resolution.

Brief Bank


