Description: This presentation will focus on how to present evidence in the forensic interview. Particular emphasis will be given to using child pornography images and explaining the how, when and why of utilizing these images.

10:15-12:00 Gaining Cooperation and the Non Supportive Caregiver

Stephanie Smith, National Child Protection Training Center Susanne Walters, National Child Protection Training Center

Description: Non-offending caregivers play a critical role from the initial outcry through the investigation, resolution and aftermath in cases of child maltreatment. MDTs should assess the attitude and response of these individuals at the outset for the benefit of the child as well as their own work. This session will discuss the impact of the non-offending caregiver for each aspect of the MDT and the child and how the team can assess the caregiver's response initially and throughout the pendency of the case. The presenters will address the ways in which a supportive caregiver can aid in the investigative and judicial process as well as how they can provide comfort and protection for the child. Also included is discussion of the risks for all involved, especially the child, when a caregiver is not supportive of the child's disclosure or is hostile to the MDT. Suggestions will be offered for how to engage a non-supportive caregiver and what to do to ensure the child's safety and protect the case if engagement efforts fail.

1:15 -2:45 Defending my Interview in Court

Rita Farrell. National Child Protection Training Center

Description: The field of forensic interviewing is a constantly evolving profession. The workshop will provide students concrete suggestions for defending their work in court and how to prepare for testifying in court. They will also learn about common cross-examination tactics and how to respond to them. Finally, students will learn how to handle themselves in a direct examination.

3:00-5:00 Interviewing Juvenile Suspects: Are Interrogations Reliable?

Description: This presentation will provide a multidisciplinary approach to the problem of juveniles' abilities to provide reliable information during interrogations about suspected crimes. A prosecutor and a forensic psychologist will consider whether juveniles should be afforded the same developmentally-sensitive interview practices as suspected victims. We will look at whether juveniles can understand the Miranda warning and investigation questions. The presentation will also examine juveniles' abilities in light of research on brain and psychosocial development.

8:00-10:00 Minimizing Miscommunication in Child Forensic Interviews

Description: Children acquire language in a cultural context. The meaning of words does not come as quickly as the use of those words when communicating. Some words are less reliable, such as pronouns and prepositions. Other words are not reliable because the cognitive processes needed to understand the use of these words have not been mastered by the child. This presentation will provide information on children's use of language as preschoolers and as school-aged children. These concepts will be applied to the process of gathering information from children in forensic interviews. By understanding children's abilities to communicate, a forensic interview can be linguistically sensitive to the child's needs and be conducted in a legally sound manner.

Description: This session will address ethical issues and practice recommendations for professionals involved in child abuse evaluations. Discussion will also cover training needs for professionals and the importance of balancing the needs of the alleged child victim and MDT members when making decisions and recommendations in child maltreatment cases.

3:45-5:00 "What a Medical Exam Can and Can't Tell You"

Ann Budzak-Garza, Gundersen Health System

Description: This workshop will focus on the medical exam for child sexual abuse. The exam process will be explained as well as ideal circumstances to prepare for the exam before the child arrives. We will review timing of exams and who should have a medical exam. Benefits of the exam to the child, family and multidisciplinary team will be discussed. Results of the exam and how this contributes to a child abuse investigation will also be presented.

8:00-10:00 Child Interviewing: Update on research and practice

Description: This presentation will provide the latest research on how interviewers can increase children's productivity through questions that are specific without being leading. The goal is to ensure that we obtain the information we need to provide adequate protection without risking suggestiveness or shutting the child down. The research will be supplemented with case studies and clips of interviews. The presentation will discuss how to make narrative practice rapport building maximally productive by emphasizing specific events.

10:15 - 11:15 Chaplains for Children: Twelve Potential Roles for a Theologian on the MDT

Victor Vieth, National Child Protection Training Center

Description: A large and growing body of research documents the frequency with which children are abused in the name of religion. When this happens, the perpetrator negatively impacts the child's sense of spirituality which, for many victims, is a primary coping mechanism. This workshop explores possible approaches for incorporating theologians into the MDT to assist in addressing spiritual injuries of maltreated children.

11:15- 12:30 Child Abuse Allegations in Custody Cases

Description: The presentation will focus on challenges that MDTs face when allegations of child abuse are present in custody cases. The presenters will discuss the impact these allegations have on investigations. The participants will learn strategies to appropriately address these types of allegations to ensure best practice.

Peer review challenges will be discussed and concrete solutions will be provided to assist in overcoming challenges.

Description: The ongoing Adverse Childhood Experiences (ACE) studies out of Kaiser Permanente and the Center for Disease Control suggest that childhood maltreatment and family dysfunction are major risk factors for the leading causes of illness, death and poor psychosocial adjustment in the United States. Cumulative adverse childhood events have a role in poor physical health, problematic health risk behaviors, learning challenges, behavior problems and disease. This presentation will introduce participants to the ACEs study, its implications for public health and the importance of an effective community response to situations of maltreatment and family dysfunction.

8:00-9:30 Working with Survivors at our Child Advocacy Centers

Howard R. Fradkin, A Center for Psychotherapy and Growth

Description: The workshop will explore issues surrounding the sexual victimization of males through the use of film and clinical case examples. Attendees will be helped to better understand the complex, and often misunderstood, dynamics of being a male survivor and some of the unique challenges and pressures faced by this population.

Included will be a defining of terms, a focus on myths surrounding male sexual victimization, distinguishing features between male and female survivors, and understanding the clinical dynamics and after-effects of abuse. A primary focus of the workshop will be on helping participants identify ways they can interview male survivors to help them feel safe enough to speak their truth. Barriers to speaking the truth will also be

Description: This presentation will discuss certified pet therapy animals, where they are being used and the efforts which created the PAWS program. The presentation will also discuss the utilization of Pet Advocates outside the court process and share examples of the power of the "puppy" in helping children disclose abuse and feel secure.

Description: Expert testimony can be compelling evidence to aid juries in the decision-making process; overstepping the bounds of what is appropriate for an expert to say on the stand can result in mistrials or retrials to the detriment of the victim and his/her family. This session will review case law critical of forensic interviewers' expert testimony and breakdown the specific concerns articulated by the reviewing court. Suggestions will be offered for tailoring the testimony to be purposeful, informative and persuasive without violating the rules of evidence or providing appeal arguments.
