Robert Murchland has 18 years of experience as a law enforcement and intelligence professional. Currently Mr. Murchland is the Intelligence Specialist with the U.S. Attorney's Office Anti-Terrorism Advisory Council for the Southern District of Ohio. Bob's prior experience includes service as a Foreign Counterintelligence analyst and Special Agent with the U.S. Air Force Office of Special Investigations and as a Police Officer with the Dayton, Ohio Police Department.

Thomas Matuszak is a Senior Assistant Prosecuting Attorney with the Lucas County, Ohio Prosecutor's Office. Mr. Matuszak received his undergraduate degree in History and Russian from Miami University, and his law degree from the University of Toledo. He has been making presentations consistently since 1999 on various legal issues. He is a former marine and has earned various commendations since he has become a prosecutor, including commendations from the FBI, U.S. DEA, and several police departments and task forces.
