1:30 – 3:00	Identifying and Combatting Gender Bias: Examining the Roles of Women Attorneys in the Movies and on TV Every legal professional regardless of gender must have an equal opportunity to advance their career in the legal profession. However, the legal profession has a history of gender bias and recent surveys, and statistical studies indicate there is still gender bias in our profession. In this

presentation, attendees will learn to identify both implicit and explicit gender bias in the legal profession by reviewing the depiction of woman attorneys on television and at the movies. In 2008 and 2018 the American Bar Association conducted a poll of the best lawyer movies. We will review film clips of these award-winning movies to identify implicit gender bias in these movies. Further, we will review the depiction of woman attorneys on classic television shows from 1960-1990 to identify gender bias on the small screen.
